## OFFICIAL SWEEPSTAKES RULES

1. **DURATION:** The promotion titled “WE'RE TAKING YOU TO THE GRAND PRIX® IN MADRID, SPAIN” (hereinafter, the “Promotion” or the “Sweepstakes”) will be conducted during the promotional period (hereinafter, the “Sweepstakes Period”), as set forth in these **Official Rules**.

During the **Sweepstakes Period**, the following will be selected:

- a. **One (1) winner** of the **International Travel Prize** for **two (2) people** to attend an **official GRAND PRIX®** race to be held in **Madrid, Spain**; and
- b. **Two (2) winners** of **Gift Certificate Prizes** for the **RACE BOX** store.

Each prize will be subject to the terms, conditions, limitations, and provisions set forth herein.

2. **SWEEPSTAKES PERIOD:** The **Sweepstakes Period** will begin on **January 1, 2026**, and will end on **May 31, 2026**.

- The **Sweepstakes** will be conducted on **June 5, 2026**. The grand prize will consist of an **International Trip** to **Madrid, Spain** for **two (2) people** (one winner and one guest) to attend the **GRAND PRIX®** scheduled to take place from **September 11 to September 13, 2026**, with an **estimated travel itinerary from September 10 to September 14, 2026**. The prize includes **tickets (“Three Day Pass”)** for all **three (3) race days** for the winner and their guest, accommodations for **four (4) days** and **three (3) nights**, and **one (1) gift certificate (“gift card”)** valued at **five hundred dollars (\$500.00)** for incidental expenses.
- Additionally, **two (2) Gift Certificate Prizes** for the **RACE BOX** store will be awarded to separate winners, independent of the travel prize, as further described in these **Official Rules**.

3. **SPONSOR:** **Ford International Business Development (“Ford”)**, Ford International Business Development Puerto Rico Office, Texaco Pl, Metro Office Park No.2, St. 1, Ste. 212, Guaynabo, Puerto Rico, 00968.

The **Sponsor** and the **Administrator** may be referred to jointly in these **Official Rules** as the “**Promotional Entities**”.

5. **PARTICIPATING DEALERS:** The Ford dealerships participating in this **Promotion** (the “**Participating Dealers**”) are: **Ford del Sur** (Ponce), **Cabrera Auto Group** (Arecibo), **Mayagüez Ford** (Mayagüez), **Fajardo Ford** (Fajardo), **Flagship Ford Carolina** (Carolina), **Caguas Expressway Motors** (Caguas), **Autos Vega** (Marginal Kennedy, San Juan), **Central Ford** (Vega Alta), and **GHP Ford** (Toa Baja).

6. **ELIGIBILITY:** All natural persons who are at least **eighteen (18) years of age** at the time their participation is generated, whether through a **valid purchase** or through the **Alternate Method of Entry** described in these **Official Rules**, who are legal residents of the Commonwealth of Puerto Rico, and who comply with all requirements set forth in these **Rules**, are eligible to participate in this **Promotion**.

In the event that the winner of the **International Travel Prize** is between **eighteen (18) and twenty-one (21) years of age**, such winner must provide written consent from a parent or legal guardian in order to redeem the **Prize**. For the **International Travel Prize**, it will be a requirement that either the winner or their guest be at least **twenty-one (21) years of age** at the time the prize is awarded.

Additionally, the winner must have a valid **credit card** in their name for purposes of hotel registration (“*check-in*”). Failure to comply with this requirement may result in the inability to use the lodging component of the prize, without giving rise to any right to additional compensation, substitution of the prize, or any liability on the part of the **Promotional Entities** and/or **Released Parties**.

a. Participation in the **Sweepstakes** may be generated exclusively through:

- the valid and completed purchase of a **new Ford vehicle** at one of the **Participating Dealers** during the **Sweepstakes Period**, in accordance with the automatic entry mechanism described below; or
- the **Alternate Method of Entry (“AMOE”)**, which does not require any purchase.

b. **Entry Through Purchase:** In the case of participation generated through the purchase of a **Ford** vehicle, the eligible participant will be the individual whose name appears as the buyer on the official purchase agreement and related contractual documentation for the transaction, and who is listed as the holder of the Vehicle Identification Number (**VIN**), subject to verification by the **Sponsor** or the **Administrator**.

**The purchase must:** have been completed within the applicable **Sweepstakes Period**; comply with the contractual requirements of the **Participating Dealer**; and must not have been canceled, rescinded, voided, or otherwise rendered ineffective at the time of the **Sweepstakes** or prior to the awarding of the prize. The cancellation, rescission, or nullification of the purchase transaction may result in the disqualification of the **Participant** or the revocation of the prize, if it has not yet been awarded.

c. **Entry Through Alternate Method (“AMOE”):** Individuals who participate through the **AMOE** will not be required to make any purchase or to be owners of a **Ford** vehicle in order to be eligible. However, they must comply with all other requirements set forth in these **Official Rules**. Entries generated through the **AMOE** will have the same odds of winning as those generated through purchase.

d. **Verification and Determination of Eligibility:** The **Sponsor** reserves the right to require, at any time and at its reasonable discretion, sufficient documentary evidence to confirm: the **Participant’s** identity; age; residency in Puerto Rico; the validity and completion of the purchase transaction, where applicable; ownership of the purchased vehicle, where applicable; and/or compliance with any other requirement set forth in these **Official Rules**.

The final determination of eligibility shall be made solely by the **Sponsor** in accordance with these **Official Rules**, subject to applicable laws and regulations. The refusal or inability of a **Participant** to provide the required documentation within the timeframe established by the **Sponsor** may result in immediate disqualification, even if such **Participant** has been notified as a potential winner.

e. **Legal Capacity to Travel:** Given that the prize consists of an international trip, the winner and their guest must comply with all applicable legal, immigration, consular, and health requirements for travel outside of Puerto Rico and the United States. In particular, the winner and their guest must have a **valid and current passport** at the time of official prize notification, with a validity of **more than six (6) months** from the start date of the trip, or any longer validity period required by the authorities of the destination country or by the policies of the travel providers. **Verification of these requirements shall constitute an essential condition for the awarding of the prize.**

In the event that the winner is between **eighteen (18) and twenty-one (21) years of age**, such winner must comply with any additional legal requirements that may apply under the laws of the

Commonwealth of Puerto Rico, the federal laws of the United States, and the laws of the destination country.

If required by law, authorization from a parent, guardian, or legal custodian for international travel must be provided in writing and duly executed in accordance with applicable law. Failure to comply with applicable legal requirements may result in forfeiture of the prize without any right to additional compensation.

The **Sponsor** shall not be responsible for the inability of the winner or their guest to comply with travel requirements, including, without limitation, obtaining or maintaining a valid passport, visa, travel authorization, required vaccinations, or any other necessary immigration requirement.

- f. **Ineligible Persons:** The following are not eligible to participate in the **Promotion**: employees of the **Sponsor** or the **Administrator**; employees or independent contractors of their respective parent companies, subsidiaries, affiliates, divisions, **Participating Dealers**, advertising agencies, public relations firms, or promotional agencies; any entity directly involved in the operation of this **Promotion**; and immediate family members up to the fourth degree of consanguinity or second degree of affinity of the aforementioned persons.

This **Sweepstakes** is limited to the geographic area of Puerto Rico and is subject to all applicable local and federal laws and regulations. **Void where prohibited.**

Strict compliance with all eligibility requirements shall be an essential condition to be declared a winner. The awarding of any prize shall be subject to the execution of the corresponding **Release of Liability and Prize Acceptance forms** and compliance with all additional requirements set forth in these **Official Rules**.

7. **METHODS OF ENTRY:** **No purchase is necessary to enter or win.** A purchase is not required to participate through **the Alternate Method of Entry** described in these **Official Rules**. Participation in this **Promotion** may be generated exclusively during the **Sweepstakes Period** through one of the following methods:

- a. **Automatic Entry Through Purchase:** Any eligible person who purchases a **new Ford vehicle** from a **Participating Dealer** during the **Sweepstakes Period** will be automatically registered to participate. The entry registration will be processed by the **Participating Dealer's** sales representative at the time the purchase transaction is completed.

**For an entry to be valid:**

- I. The transaction must be completed within the **Sweepstakes Period**.
- II. The purchase agreement must be signed and not subject to cancellation, rescission, or voidance at the time the prize is awarded.
- III. The purchaser's information must be entered completely and accurately into the system or mechanism designated by the **Sponsor** or the **Administrator**.
- IV. The information must be received and validated by the official **Sweepstakes** administration system.

An entry will be considered officially registered only once it has been properly received, validated, and included in the **Official Entry Registry**. Each valid purchase transaction will generate **one (1) independent entry** into the **Sweepstakes Period**. In the event that an individual completes multiple valid purchases in separate transactions during the **Sweepstakes Period**, each valid purchase will generate an additional independent entry.

The **Sponsor** and the **Administrator** shall not be responsible for omissions, errors, negligence, or failures by the dealer or its personnel in entering the purchaser's information, provided that the **Sponsor** has established reasonable mechanisms for the collection and transmission of such information. The **Participant** is responsible for verifying that the information provided at the time of purchase is accurate and complete.

- b. **Alternate Method of Entry ("AMOE")**: No purchase is necessary to enter or win. Eligible individuals may participate without purchasing a new **Ford** vehicle by visiting the **Promotion Administrator's** offices in person, located at 9 Munet Court, Guaynabo, P.R. 00968, on **Wednesdays**, during limited hours from **10:00 a.m. to 12:00 p.m.**, and during the **Sweepstakes Period**. Upon arrival at the **Administrator's** offices, the **Participant** must complete an **official entry form**. The **Sponsor** reserves the right to expand the days or hours of participation for the **AMOE**, as deemed necessary to ensure reasonable access for participants.

The **Participant** must complete the form in its entirety with truthful information, including, without limitation: **full name**; **physical** or **mailing address** in Puerto Rico (P.O. Box permitted); **telephone number**; **date of birth**; **email address**; and **any other information reasonably required** for the administration of the **Sweepstakes**.

Incomplete, illegible, altered, or late submissions will be declared void and will not be included in the **Sweepstakes**. Each person may submit only **one (1) entry** through the **AMOE** during the **Sweepstakes Period**. By using this alternate method of entry, the **Participant** agrees to the **Official Rules** and **Terms and Conditions** of the **Sweepstakes**, confirming that they have read and accepted them.

- c. **Registration, Validation, and System Integrity**: An entry will not be considered valid until it has been properly received, validated, and incorporated into the **Official Registry** for the **Sweepstakes Period**. The **Sponsor** shall not be responsible for entries that are not registered due to: human error; technical failures; connectivity issues; system interruptions; data loss; transmission errors; unauthorized third-party intervention; or any circumstance beyond its reasonable control.

The **Sponsor** reserves the right, subject to applicable law, to suspend, modify, or cancel the registration process if it determines that the integrity of the system or the **Sweepstakes** has been compromised by fraud, unauthorized intervention, or a material technical error.

- d. **Accuracy of Information and Disputes**: All information provided must be truthful, complete, and accurate. Any entry containing false, incomplete, incorrect, or misleading information will be disqualified, even if it has been preliminarily selected as a winner. In the event of a dispute regarding the identity of a **Participant**, the authorized **Participant** will be deemed to be the individual whose name appears in the official purchase records or on the validated **AMOE** form for the **Sweepstakes Period**. The **Sponsor** may require reasonable evidence to confirm ownership of the entry.

- e. **Odds**: All eligible entries have the same chance of winning. The odds of winning will depend on the total number of eligible entries received during the **Sweepstakes Period**.

8. **GENERAL CONDITIONS OF PARTICIPATION**: Participation in this **Promotion** constitutes an express, voluntary, and irrevocable acceptance of each and every provision contained in these **Official Rules**. Full and strict compliance with these **Rules** shall be an essential condition to be declared a winner. Failure to comply with any of these terms may result in the immediate disqualification of the **Participant**, even if such **Participant** has been preliminarily notified as a potential winner.

- a. **Right of Disqualification and Process Control:** The **Sponsor** reserves the right, at its reasonable discretion and in accordance with these **Rules** and applicable laws, to disqualify any **Participant** who: fails to meet the eligibility requirements; provides false, incomplete, inconsistent, or misleading information; submits an entry that is invalid or contrary to these **Rules**; attempts to manipulate, alter, or interfere with the proper operation of the **Sweepstakes**; acts in violation of law; or engages in conduct that materially affects the integrity, transparency, fairness, or proper administration of the **Promotion**. The exercise of this right shall be carried out in good faith and solely for the purpose of preserving the legality and legitimacy of the promotional process.
- b. **Conditional and Revocable Nature of Selection:** Notification of a **Participant** as a potential winner constitutes a preliminary, conditional, and revocable selection. No final awarding of the prize shall occur until:
- I. Compliance with all eligibility requirements has been confirmed;
  - II. The information provided has been validated;
  - III. The verification process determined by the **Sponsor** has been completed;
  - IV. The potential winner has signed the **Release of Liability and Prize Acceptance forms**;
  - V. The potential winner presents a passport with a validity of more than **six (6) months** from the start date of the trip and complies with all additional requirements applicable to international travel;
  - VI. It is confirmed that no circumstance has occurred that invalidates the entry; and
  - VII. The prize has been effectively delivered.
- Until the prize has been effectively delivered, the **Participant** shall not acquire any right, protected expectation, title, or legal interest in the prize. The **Sponsor** may revoke a preliminary selection if any non-compliance is detected after notification.
- c. **Resolution of Administrative Disputes:** Any dispute related to: the identity of a **Participant**; the ownership of an entry; the validity of an entry; the interpretation of these **Rules**; the eligibility of a potential winner; and/or the preliminary or final awarding of a prize, shall be resolved by the **Sponsor** in accordance with these **Rules** and applicable laws. The **Sponsor's** determinations shall be made in good faith, within reasonable parameters, and shall be final and binding for administrative purposes of this **Promotion**, subject at all times to applicable laws and regulations.
- d. **Fraudulent, Abusive Conduct or Manipulation:** Any attempt to: obtain a prize through fraud, deceit, or misrepresentation; use third-party information without authorization; submit false or altered documents; generate multiple entries through unlawful means; manipulate systems, processes, or records; and/or interfere with the normal operation of the **Sweepstakes**, will result in the immediate disqualification of the **Participant** and the invalidation of all of their entries during the **Sweepstakes Period**, even if such **Participant** has been notified as a potential winner. The **Sponsor** may refer any conduct it deems fraudulent or unlawful to the appropriate authorities and may exercise all available legal remedies.
- e. **Administrative, Technical, or Material Errors:** The **Sponsor** shall not be responsible for unintentional administrative, human, technical, or typographical errors that do not materially alter the essential nature of the **Promotion**. In the event of a manifest, material, or systemic error that materially affects the integrity of the **Sweepstakes**, the **Sponsor** may take reasonable corrective measures, including, without limitation: correcting the error; repeating the selection process;

invalidating affected entries; suspending or modifying the promotional process; all subject to applicable laws and regulations.

- f. **Precedence of Official Records:** In the event of any discrepancy among electronic records, communications, physical forms, printed copies, or any other evidence related to the **Promotion**, the official records maintained by the **Sweepstakes Administrator** shall prevail.
  - g. **Absence of Vested Rights and Legal Relationship:** Participation in this **Promotion** does not create any contractual relationship other than the acceptance of these **Official Rules**, nor does it confer any vested right, legally protected expectation, or claim of any kind until the final awarding and effective delivery of the prize have been completed.
  - h. **Interpretation, Integrity, and Enforcement:** The **Sponsor** reserves the right to interpret these **Rules** and to make reasonable decisions necessary to ensure the integrity, fairness, transparency, and legality of the **Promotion**, in accordance with the laws and regulations of the Commonwealth of Puerto Rico.
9. **PRIZES AND SELECTION OF WINNERS:** During the **Sweepstakes Period**, the following will be selected electronically and at random:
- **One (1) winner of the International Travel Prize;**
  - **Five (5) alternate winners for such International Travel Prize;**
  - **Two (2) winners of the Gift Certificate Prize; and**
  - **Five (5) alternate winners for the Gift Certificate Prizes.**

The selection will be conducted through an electronic random selection system at the offices of the **Promotion Administrator**, or at such location as determined by the **Sponsor**, in accordance with applicable laws and regulations. **All eligible entries have the same chance of winning. The odds of winning will depend on the total number of eligible entries received during the Sweepstakes Period.**

- A. **INTERNATIONAL TRAVEL PRIZE:** During the **Sweepstakes Period**, **one (1) prize** will be awarded consisting of an **International Trip to Madrid, Spain for two (2) people** (one winner and one guest) to attend the **GRAND PRIX®**, the details of which are set forth below:
- a. **GRAND PRIX® to be held in the city of Madrid, Spain:**
    - **Races scheduled from September 11 to September 13, 2026**
    - **Estimated travel itinerary: September 10 to September 14, 2026**
  - b. **Travel Prize Components:**
    - **Two (2) round-trip economy class airline tickets from Puerto Rico;**
    - **Approximately four (4) days and three (3) nights of accommodations;**
    - **Official tickets (“Three Day Pass”) for all three (3) race days for the winner and their guest in *Grandstand Ticket Silver S.10*;**
    - **One (1) gift certificate (“gift card”) valued at five hundred dollars (\$500.00) as a stipend for incidental expenses.**
  - c. **Approximate Retail Value:** The **Approximate Retail Value (“ARV”)** of the **travel prize is six thousand five hundred dollars (\$6,500.00)**. Such value constitutes a reasonable estimate and may vary based on availability, airfare, taxes, and market conditions. All

components of the prize are subject to availability and to the terms and conditions of the respective suppliers.

- d. **Essential Conditions of the Travel Prize:** The trip must be taken strictly on the specified dates, and no date changes, extensions, substitutions, transfers, or cash compensation will be permitted. If the winner is unable to travel on the specified dates for any reason, the prize will be forfeited without compensation and awarded to the corresponding alternate winner.

The prize is non-transferable and may not be redeemed for cash or for other goods or services. The prize includes only the components expressly described in these **Official Rules**. Accordingly, the prize **does not include**, among other things: ground transportation (including local transportation or transportation related to official event activities), meals, beverages, personal expenses, gratuities, additional insurance, baggage fees, or any other incidental expenses not specified.

The winner must present a valid **credit card** in their name at the time of hotel *check-in* to cover incidental charges. The prize is subject to the terms and conditions of airlines, hotels, event organizers, and other third-party suppliers.

The **Sponsor** shall not be responsible for cancellations, delays, itinerary changes, governmental restrictions, weather conditions, labor disputes, or any other circumstance beyond its reasonable control.

- e. **Travel Insurance:** The prize does not include travel insurance. The acquisition of such coverage shall be the sole responsibility of the winner and their guest. The absence of such insurance shall not create any additional obligation on the part of the **Sponsor**.

- B. **GIFT CERTIFICATE PRIZE:** During the **Sweepstakes Period**, **two (2) prizes** will be awarded consisting of:

- a. **One (1) gift certificate** in the amount of **two hundred fifty dollars (\$250.00)** for each winner, to be used for the purchase of merchandise at the **RACE BOX** store located at **The Mall of San Juan** in Puerto Rico. The total **approximate retail value ("ARV")** of the certificates is **five hundred dollars (\$500.00)**. The certificates will be subject exclusively to the terms, conditions, commercial policies, inventory availability, and restrictions established by **RACE BOX**.

- b. **Specific Provisions Regarding RACE BOX:** **RACE BOX** is not a sponsor, administrator, or co-organizer of this **Promotion**. The **Sponsor** and the **Administrator** assume no responsibility for: product availability or quality; exchange or return policies; product warranties; commercial restrictions or limitations; and/or the cancellation or modification of store operations. Acceptance and use of the certificate constitutes an express release in favor of the **Sponsor** and the **Administrator** with respect to any claim related to the redemption of the certificate or the products acquired. Any claim related to purchased merchandise must be directed solely to **RACE BOX**.

The certificates are non-transferable, non-redeemable for cash, and may not be substituted, except as otherwise provided in these **Official Rules**.

10. **ALTERNATE WINNER SUBSTITUTION:** For both the **travel prize** and the **gift certificate prizes**, **five (5) alternate winners** will be selected for each type of prize, in the order drawn. If a winner: cannot be contacted within the specified timeframe; fails to sign the required documentation; does not meet the eligibility requirements; is unable to travel on the specified dates (if applicable); or fails to comply with these **Official Rules**; the corresponding prize will be awarded to the next alternate

winner in the order of selection. If the list of alternates is exhausted without awarding the prize, such prize will not be awarded.

11. **TRADEMARKS AND NON-AFFILIATION:** “**Formula 1**,” “**F1**,” and any other name, logo, design, trademark, expression, or reference related to the **GRAND PRIX®** are registered trademarks and/or intellectual property of their respective owners. Likewise, “**RACE BOX**” and any other brand, business, establishment, or provider related to the prizes offered in this **Promotion**, including, without limitation, the issuing brand of any gift certificate (“*gift card*”), are the property of their respective owners.

This **Promotion** is not affiliated with, sponsored, endorsed, administered by, or in any way associated with the owners of such trademarks, the entities organizing the **GRAND PRIX®**, race promoters, circuit operators, teams, drivers, official sponsors, **RACE BOX**, any issuer of gift certificates, or any other person or entity directly or indirectly related to the organization, production, administration, or provision of the prizes or the sporting event.

The use of such names in these **Official Rules** is solely for descriptive purposes to identify the event and/or the prizes offered and does not imply any endorsement, authorization, commercial relationship, or sponsorship. **Nothing in these Rules shall be construed as granting any license, authorization, or right to use such trademarks beyond the descriptive use stated herein.**

12. **WINNER PUBLICATION:** The names of the winners may be obtained by submitting a written request to the **Promotion Administrator** within **thirty (30) days** from the date of the **Sweepstakes**.
13. **NOTIFICATION, ACCEPTANCE, AND PRIZE FULFILLMENT:** Each potential winner will be notified by **telephone** and/or **email** using the information provided in their entry on the day of the **Sweepstakes** or within a reasonable time thereafter. The **Sponsor** will make at least **three (3) reasonable attempts** to contact the potential winner on different days and at different times by **telephone** and/or **email**. If effective communication with the potential winner is not achieved after such attempts, the potential winner may be disqualified and the corresponding alternate winner will be contacted. Such notification shall constitute a **preliminary and conditional selection**, subject to compliance with all requirements set forth in these **Official Rules**.
- a. **Acceptance Period:** The potential winner must, within **seven (7) calendar days** from the date on which the notification is received (the “**Period**”):
- I. Confirm in writing acceptance of the awarded prize;
  - II. Complete and sign the corresponding **Release of Liability and Prize Acceptance forms**;
  - III. In the case of the travel prize, confirm the identity of their guest and provide a copy of a valid passport for both the winner and the guest, in accordance with the requirements set forth in these **Official Rules**;
  - IV. Provide any other information reasonably required by the **Sponsor** for the coordination, fulfillment, and delivery of the corresponding prize within the timeframe established by the **Sponsor**.

In the case of the **RACE BOX gift certificates**, the winner must also coordinate the method of delivery of the certificate, which may be provided electronically or through in-person pickup, as determined by the **Sponsor** and in accordance with the instructions provided to the winner.

Failure to comply with any of these requirements within the **Period** will result in the automatic forfeiture of the awarded prize and its award to the corresponding alternate winner, without any liability on the part of the **Sponsor** or the **Administrator**.

- b. **Electronic Execution and In-Person Appearance:** The “**Release of Liability and Prize Acceptance**” forms may be completed and submitted electronically within the established **Period**. Notwithstanding the foregoing, in the case of the **international travel prize**, it shall be an essential requirement that the winner appear in person, by prior appointment, at the offices of the **Promotion Administrator** located at 9 Munet Court, Guaynabo, Puerto Rico 00968, or at such location as the **Sponsor** may determine and timely communicate, in order to: verify their identity; present a copy of their valid and current passport, as well as that of their guest, both of which must comply with the validity requirements set forth in these **Official Rules**; provide any additional documentation reasonably required for the coordination of the trip; and/or sign the **Releases** in person, if they have not been previously submitted in original signed form or if additional validation is required.

**The presentation and validation of the passports of both the winner and their guest, in accordance with these Rules, shall constitute an essential condition for the final awarding of the prize.**
